This Bulletin modifies Articles 4° & 5°, Paragraph 7, Bulletin N°004 11th December 2020, “*This bulletin announces and rules the **PAN-AMERICAN ROLLER SPEED SKATING NATIONS CHAMPIONSHIP 2020, FOR CLUBS & NATIONS**, to be held in Ibagué, Colombia, 20th – 31st January 2021*”.

World Skate America (WSA) President,

CONSIDERING

that after the **World Skate América (WSA)** Technical Commission analysis, it is necessary to modify and to reduce the number of participant skaters of the **PAN-AMERICAN ROLLER SPEED SKATING NATIONS CHAMPIONSHIP 2020, FOR CLUBS & NATIONS**, to be held in Ibagué, Colombia, 20th – 31st January 2021”;

that it is necessary to adjust the World divisions Clubs and Nations Teams registration process in what the limit of participant skaters per race is concerned;

DECIDES

ARTICLE 1° To modify Article 4° Clubs World Divisions, from Bulletin N° 004 11th December 2020, as follows:

Limit of participant skaters per race for Clubs World Divisions:

GROUP	DIVISIONS	LIMIT OF PARTICIPANTS SKATERS
CLUBS WORLD DIVISIONS	PreJunior 14 years	<ul style="list-style-type: none">○ Up to two (2) skaters for Individual races (100 m. 200 m. Dual TT) by team and division.○ Up to three (3) skaters for Sprint races (One Lap, 500 m. + D & 1.000 m.).○ Up to three (3) skaters for Long Distance races (Elimination on Track & Road, Points + Elimination on Track, Points on Road).
	Junior 15 to 18 years	
	Senior 19 years and older	



ARTICLE 2° To modify Article 5°, Paragraph 7 from Bulletin N° 004 11th December 2020, as follows:

ARTICLE 5. NATIONS DIVISIONS

PARAGRAPH 7. Limit of participant skaters per race for Nations Senior Division:

GROUP	AGE	LIMIT OF PARTICIPANTS SKATERS
NATIONS SENIOR	Older than 19 years old	<ul style="list-style-type: none">○ Up to two (2) skaters per gender (Ladies & Men) for individual races.○ Up to two (2) skaters per gender (Ladies & Men) for group Sprint races.○ Up to three (3) skaters per gender (Ladies & Men) for Long Distance races.
