



RESOLUTION No. 003
February 12, 2021

By means of which a paragraph is added to article 12° of Resolution No. 004 of December 2020; which summons and regulates the **PAN AMERICAN SPEED SKATING NATIONS CHAMPIONSHIP 2020 IN THE CATEGORIES OF CLUBS AND NATIONS**, to be held in the city of Ibagué, Colombia, from February 4 to 14, 2021.

The President of World Skate America WSA, in use of his legal attributions, statutory and;

CONSIDERING

- That the Pan American Calendar 2020 of World Skate America (WSA) foresees the holding of the **PAN AMERICAN SPEED SKATING NATIONS CHAMPIONSHIP 2020 IN THE CATEGORIES OF CLUBS AND NATIONS**, to be held in the city of Ibagué, Colombia, from February 4 to 14, 2021.
- That it is a commitment of WSA Executive Committee to hold events at the continental level.
- That the **PAN AMERICAN SPEED SKATING CHAMPIONSHIP OF NATIONS 2020, IN THE CATEGORY OF NATIONS - U23**, is a qualification event for the Pan American Junior Games to be held in Santiago de Cali, Colombia in September 2021.

RESOLVES

ARTICLE 1. THE ARTICLE 12 shall be as follows:

ARTICLE 12. RANKING FOR THE QUALIFICATION FOR THE PAN AMERICAN GAMES.

The ranking for the qualification for the Pan American Junior Games 2021, to be held in Santiago de Cali, will be established with the following scoring system, in the Junior Nations male and female categories:

PARAGRAPH. In the case of, based on the points of the ranking, it is not possible to complete all the quotas assigned by PANAM SPORT, an additional scoring table will be established for each of the events of the actual number of athletes competing in the same, assigning the highest score to the first of them and so on in descending order awarding each athlete the corresponding points until reaching the last of them.

This ranking will make it possible to complete the athletes classified from those countries that have not yet obtained their respective quota.

ARTICLE 20. VALIDITY. – This resolution shall be valid from the date of its issue.
