



**RESOLUTION No. 004**  
**February 19, 2021**

By means of which Articles 1°, 5°, 10°, and 11°, of Resolution No. 006 of December 14, 2020, "which is summoned and regulated the **PAN AMERICAN INLINE HOCKEY OF NATIONS CHAMPIONSHIP 2020 IN THE CATEGORIES OF JUNIOR AND SENIOR FOR WOMEN AND MEN**, to be held in the city of BOGOTÁ D.C., Colombia, from February 23 to 28, 2021", are modified.

The President of the **World Skate America (WSA)**, in use of his legal attributions, statutory and;

**CONSIDERING**

That after meetings held with the Colombian authorities on behalf of the Official National and District Entities, regarding the situation experienced by the pandemic and taking into account the preventive management that has been implemented in the city of Bogotá, D.C., the venue of the event in the first half of the year.

That in agreement with the Colombian Skating Federation as the organizer of the Pan American Event, the guidelines, and recommendations of the District and National authorities have been and will continue to be followed.

That in order to take this decision, the evident control that the District authorities have achieved over the pandemic was taken into account.

That the endorsement given to the Pan American Event by the Colombian Ministry of Sports was taken into consideration, as indicated in its communication: ... "in the exhaustive review made to the content and the established biosecurity procedures, it is found that they fully comply with the criteria established by the Ministry of Health, guaranteeing the health conditions of all the members of the organization and athletes that will participate in the competitions of the **PAN AMERICAN INLINE HOCKEY OF NATIONS CHAMPIONSHIP 2020 IN THE CATEGORIES OF JUNIOR AND SENIOR FOR WOMEN AND MEN**".

That after the respective analysis and by the disposition of the Technical Committee of Inline Hockey of the **World Skate America (WSA)**, it is necessary to modify the date of the **PAN AMERICAN INLINE HOCKEY OF NATIONS CHAMPIONSHIP 2020 IN THE CATEGORIES OF JUNIOR AND SENIOR FOR WOMEN AND MEN**, to be held in the city of Bogotá, Colombia.



That in analyzing the times and dates established for the competitions, it is necessary to adjust the training calendar for judges and coaches, in order to achieve a greater participation of stakeholders.

## RESOLVES

**ARTICLE 1°.** Modify article 1°. **ANNOUNCEMENT**, of Resolution No. 006 of December 14, 2020, which will remain as follows:

To summon all the National Teams of the National Federations affiliated to WSA to participate in the **PAN AMERICAN INLINE HOCKEY OF NATIONS CHAMPIONSHIP 2020 IN THE CATEGORIES OF JUNIOR AND SENIOR FOR WOMEN AND MEN**, to be held in the city of Bogotá, Colombia, from March 15 to 21, 2021.
