



RESOLUTION N° 007
April 3rd, 2021

By means of which article 1° of Resolution N° 002 of January 21st, 2021 is modified and the new date of the **PAN AMERICAN ARTISTIC SKATING OF CLUBS AND NATIONS CHAMPIONSHIP 2020** is established.

The President of World Skate America, in use of his legal attributions, statutory and;

CONSIDERING

That World Skate America by request of the Presidents of the National Federations extended the programming of the continental calendar 2020, until May 10th, 2021.

That the Pan American Calendar 2020 foresees the holding of the PAN AMERICAN ARTISTIC SKATING OF CLUBS AND NATIONS CHAMPIONSHIP 2020, in the city of Guayaquil - Ecuador, from April 12th to 25th, 2021.

That by Resolution N° 002 of January 21st, 2021, World Skate America modified the dates of registration and holding of the PAN AMERICAN ARTISTIC SKATING OF CLUBS AND NATIONS CHAMPIONSHIP 2020.

Those guidelines and mobility restrictions have been issued in different countries of South America, with the purpose to protect the health of the citizens and thereby prevent infections as a result of the COVID 19 pandemic.

That National Delegations registered for the Pan American event have reported difficulties due to the cancellation of scheduled flights and difficulties in obtaining airline tickets to attend the Pan American Championship.

That the judges summoned to the event have reported difficulties in obtaining airline tickets to attend the Pan American Championship.



That after consultation with the Presidents of WSA member countries, and in agreement with their respective governments, the need to postpone again the Pan American Artistic Skating Championship in Guayaquil, keeping the venue in this city, was raised.

That in agreement with the Ecuadorian Skating Federation as the organizer of the Pan American Event, it has been decided to change the date of the Pan American Artistic Skating event, in order to comply with the guidelines of the health authorities regarding the pandemic and allow all registered countries to participate.

That the Pan American Calendar 2020 foresees the holding of the PAN AMERICAN ARTISTIC SKATING OF CLUBS AND NATIONS CHAMPIONSHIP 2020, in the city of Guayaquil, Ecuador.

That it is necessary to change the dates established in the articles of Resolution N° 002 of January 21st, 2021, to allow the delegations of the different countries to participate in the Pan American event.

RESOLVES

ARTICLE 1° DATES OF THE CHAMPIONSHIP. Change the dates established in article 1° of Resolution N° 002 of January 21st, 2021, for the holding of the Pan American Artistic Skating of Clubs and Nations Championship 2020, which will be held from May 3rd to 9th, 2021, with the following schedule:

Accreditations and Training	May 3, 2021
Pan American of Clubs and Nations – Simultáneo	May 3-9, 2021
Clubs and Nations Competitions	May 4-9, 2021



ARTICLE 2° REGISTRATION. In the event that a country or club needs to include new athletes interested in participating in the Pan American Artistic Skating Championships, they must apply directly to WSA General Secretariat for authorization.

Paragraph. The deadline to do so will be until April 20th, 2021.

ARTICLE 3° VALIDITY. This resolution shall be valid from the date of its issue. Issued this 3rd day of April 2020 at Bogotá D.C., city.
