



RESOLUTION No. 009
June 20th, 2021

By means of which articles 1° and 5° of Resolution No. 008 of April 22nd, 2021, "**By which the PAN AMERICAN OF NATIONS JUNIOR UNDER19 MEN, SENIOR MEN AND SENIOR WOMEN OF RINK CHAMPIONSHIP**, that will be held in the city of Fort Pierce - Florida from the 16th to the 26th of September 2021" are modified.

The President of World Skate America, in use of his legal attributions, statutory and;

CONSIDERING

That World Skate America by request of the Presidents of the National Federations decided to change the date of holding of the Pan American event and extend the registration date for the PAN AMERICAN OF NATIONS JUNIOR UNDER19 MEN, SENIOR MEN AND SENIOR WOMEN OF RINK CHAMPIONSHIP, that will be held in the city of Fort Pierce - Florida from the 16th to the 26th of September 2021.

That World Skate America has decided to change the date of holding and extend the registration date of the PAN AMERICAN OF NATIONS JUNIOR UNDER19 MEN, SENIOR MEN AND SENIOR WOMEN OF RINK CHAMPIONSHIP, that will be held in the city of Fort Pierce - Florida from the 16th to the 26th of September 2021 with the purpose to allow greater participation in the sporting event.

That World Skate Calendar foresees the holding of the PAN AMERICAN OF NATIONS JUNIOR UNDER19 MEN, SENIOR MEN AND SENIOR WOMEN OF RINK CHAMPIONSHIP, that will be held in the city of Fort Pierce - Florida from the 16th to the 26th of September 2021.

That it is the duty of World Skate America, to regulate all the events of the official calendar of all skating modalities.

RESOLVES

ARTICLE 1°. CONVOCATORIA – Convening the PAN AMERICAN OF NATIONS JUNIOR UNDER19 MEN, SENIOR MEN AND SENIOR WOMEN OF RINK CHAMPIONSHIP, that will be held in Arena Fort Pierce -Florida (2000 Virginia Ave, Fort Pierce, FL 34982) from the 22nd to the 26th of September 2021.



ARTICLE 2°. REGISTRATION – For the Nations event, each country may enter only one team in each of the categories and disciplines of the tournament.

Registration will be received ONLY on the WORLD SKATE AMERICA official form for Rink Hockey Championships. This form must be filled out completely (names, jersey numbers, date of birth, ID, or license number of each Federation) on a computer and should be sent via e-mail only by the Federations to cthp@worldskateamerica.org.

ORDINARY Registration will be received until July 23rd, 2021, and EXTRA-ORDINARY Registration until July 30th, 2021.

The values and amounts for registration of Countries and Athletes are stipulated by WORLD SKATE AMERICA in its bulletin of fees as follows and always USD North American dollars:

The registration fee will be paid in cash per team in each category and discipline, at the facilities provided by WORLD SKATE AMERICA for the accreditation and technical meeting, which will be informed in due course.

ARTICLE 3°. VALIDITY. This resolution shall be valid from the date of its issue.
