

RESOLUTION No. 005

April 25th, 2023

To invite and regulate the PAN AMERICAN CUP OF FIGURES 2023, for Clubs for Promotional levels and Nations for World Class Level, to take place at Rio Negro, Colombia from August 8th to 10th, 2023

The President of World Skate America, in use of his legal attributions, and;

CONSIDERING

• That the Pan American Calendar 2023 provides for the realization of a PAN AMERICAN CUP OF FIGURES 2023.

• That one of the duties of World Skate America is to regulate all the events of the official calendar for all the disciplines of skating.

RESOLVES:

ARTICLE 1° ANNOUNCEMENT

To invite and regulate the PAN AMERICAN CUP OF FIGURES 2023.

PARAGRAPH 1 EFFICIENCY LEVELS AND CATEGORIES

- CLUBS AT PROMOTIONAL LEVEL, in three efficiencies, basic, intermediate, and advanced.
 Categories tots, mini, espoire, cadet, youth, junior and senior for ladies and men.
- **NATIONS AT WORLD CLASS LEVEL**, categories tots, mini, espoir, cadet, youth, junior and senior for ladies and men.

PARAGRAPH 2 TECHNICAL RULES

In Nation's event, competition will be held with World Skate regulations.

For the promotional event, two (2) or three (3) figures will be skated for each efficiency according to the following table. Each figure must be skated Two (2) times without stopping after the initial start.

PARAGRAPH 3 - No athlete may enter two different categories or efficiencies. That is, each athlete will have only one participation.

PARAGRAPH 4 - Athletes who participated in world championship, cannot participate in a minor category or efficiency at the PAN AMERICAN CUP OF FIGURES 2023.

ARTICLE 2 DATES AND VENUE

Tentative dates (these dates could change by one day, by request of Worls Skate America ATC, according to the number of skaters in each event): From August 8th to 10th, 2023.

The venue for this event is Unidad Deportiva Ivan Ramiro Cordoba on 43rd St. N°50 – 200 Rionegro, Antioquia.

ARTICLE 3 ORGANIZATION

World Skate America and the Colombian Skating Federation will be responsible for the organization of the event in administrative and logistical aspects and the technical committee of figure skating the technical sports aspects.

ARTICLE 4 PARTICIPANTS

To be eligible to participate, athletes from nations, leagues, clubs, associations need their National Federation authorization.

ARTICLE 5 LIMIT OF REGISTRATIONS

Athletes

- Club Event: each club may register up to five (5) athletes per efficiency, category, and gender.
- For Nation's event, a maximum of three (3) athletes per category, and gender per country will be allowed.

Support personnel:

- For Clubs event, each club will have the right to register up to two (2) coaches plus one (1) delegate.
- For the nations event, each nation may register up to two (2) coaches plus one (1) delegate.

PARAGRAPH. The registration for coaches and delegates for the club event will not be valid for the nations event.

ARTICLE 6 PENALTIES AND TEMPORARY INELIGIBILITIES

Any Club, Association, Confederation and/or Federation with registered athletes, that do not show up to the event or that, while registered, do not show up for a particular event, will be sanctioned or disqualified as stipulated by the WSA.

The penalty payment is mandatory to regain the right to participate in another competition.

PARAGRAPH 1 Athletes, clubs, Confederations and/or Federations will be exempt from the penalties described in article 6:

• Submitting a justification letter signed by an official doctor previously verified by their National Federation.

• For reasons of force majeure, verified by the WSA Artistic Skating Technical Committee and authorized by the WSA president.

PARAGRAPH 2 In case an organization or athlete is exempted from the established ineligibilities, it is not exonerated from the registration payment.

PARAGRAPH 3 Athletes and/or clubs that engage in any of the ineligibilities described in this article, will have three (3) days after the event, to present a written justification for their non-attendance, with the supporting documents to the e-mail inscripcionespanamericano@gmail.com.

ARTICLE 7 AWARDS

For Clubs, medals will be awarded to the athletes who occupy the first four places in each event, by gender and discipline, as follows: 1 gold, 1 silver and 2 bronzes.

For Nations, medals will be awarded to the athletes who occupy the first three places in each event, by gender and discipline, as follows: 1 gold, 1 silver and 1 bronze. If the first three places are skaters from the same country, the bronze medal will be given to the next place from a different country to avoid a single country podium.

ARTICLE 8 DRAWS AND SKATING ORDERS

The figures group will be drawn and sent to the clubs and nations prior to the event and starting foot will be drawn at the technical meeting.

The skating order will be drawn electronically and will be published in advance for review and correction prior to the technical meeting.

ARTICLE 9 REGISTRATIONS

By disposition of World Skate America, the registrations of the clubs and nations must be sent through the Federation and/or Confederation to which they belong; registrations sent individually by each club or association will not be accepted.

The registration must be sent according to the dates established below by e-mail at inscripcionespanamericano@gmail.com.

The form published on the World Skate America website must be used, without converting it to PDF or image. Different formats will not be accepted.

PARAGRAPH 1 - 1 The ORIGINAL form, signed by the club and Federation, must be submitted on the accreditation process. Without this document, this process cannot be

finished. Those incomplete registrations presented in a different format will be considered as not received.

PARAGRAPH 2 - Claims will not be accepted from clubs, associations, or national teams whose delegates are not present at the brief meeting.

ARTICLE 10 ENTRY FEES

PARAGRAPH 1 - Registration payments must be made in cash in US dollars, or the official conversion to Colombian pesos (dollar TRM) by the delegate according to the detailed program to be published.

PARAGRAPH 2 - All federations and/or Confederation that have athletes participating in the Pan American Championship, must be in compliance with World Skate America's regulations.

ARTICLE 11 - COMPLAINTS

Word Skate rules will be followed.

ARTICLE 12 - AUTHORITIES OF THE EVENT

- ✓ World Skate Americas President will nominate the event manager.
- \checkmark The highest judging authority will be the technical officials.
- ✓ The disciplinary committee will be comprised by the event referee, one of the Pan American Commission delegates, and a representative designated by the event Host Federation.
- ✓ The maximum administrative authority will be the World Skate America's President who will be the head for the Event Management Committee.

ARTICLE 13 - EVENT MODIFICATION OR CANCELLATION

Only the World Skate America Artistic Skating Technical Committee can modify or cancel a certain event that does not comply with the competition conditions, due to rink space, lack of time, lack of competitive level, guarantees, or unforeseen delays in the programming.

ARTICLE 14 – TECHNICAL MEETING

The informative meeting of the event will be held in the place and time that the organization of the event has for this purpose and that will be announced in the official invitation. For this meeting, the presence of all the coaches who are registered in the respective forms and the judges who have been summoned is requested.

PARAGRAPH 1 - Once the informative meeting is concluded, the meeting of judges will be held in the same room.

ARTICLE 15 - LIABILITY IN ACCIDENTS

World Skate America and the Colombian Skating Federation are not responsible for accidents that may occur during the event, which is why all skaters must have current medical and/or accident insurance, ORIGINAL documents that must be presented at the time of the respective accreditations.

ARTICLE 16 VALIDITY

This resolution shall be valid from the date of its issue.
