By means of which the **PAN AMERICAN INLINE HOCKEY CLUB CHAMPIONSHIP 2024** is summoned and regulated, to be held in the city of **IBAGUE from August 7th to August 18th, 2024.**

The President of WORLD SKATE AMERICA WSA and the PAN AMERICAN INLINE HOCKEY COMMISSION in use of their Legal and Statutory attributions and:

WHEREAS:

- That WORLD SKATE AMERICA contemplates in its continental calendar 2024, the **Pan American championships of Inline Hockey Clubs in the categories U8, U10, U12, U14, U16, WOMEN's OPEN and MEN's OPEN.**
- That it is the duty of WORLD SKATE AMERICA to regulate the practice of Inline Hockey for all its official Pan American events and which will be responsible for organizing the Pan American championships of Nations.

TERMS:

ART. 1º. - To summon all the clubs of the Pan American area to participate in the PAN AMERICAN CHAMPIONSHIP OF INLINE HOCKEY CLUBS, to be held in the city of Ibagué, for the categories: U8, U10, U12, U14, U16 WOMEN, U16 MEN, WOMEN's OPEN and MEN's OPEN, from AUGUST 07 to AUGUST 18, 2024.

PARAGRAPH 1. CATEGORIES AND AGES, the PAN AMERICAN CLUB HOCKEY LINE HOCKEY CHAMPIONSHIP 2024 will be held in the following categories and in the following manner:

- **U8 coed category:** Athletes born in year 2016-2015
- **U10 coed category:** Athletes born in year 2014-2013
- **U12 coed category:** Athletes born in year 2012-2011
- **U14 coed category:** Athletes born in year 2010-2009
- **U16 girls category:** Athletes born in year 2008-2007
- **U16 boys category:** Athletes born in year 2008-2007
- **WOMEN's OPEN Category:** Athletes born in year 2010 and earlier
- **MEN's OPEN Category:** Athletes born in the year 2008 and earlier

ART. 2 - CITIES AND DATES, the PAN-AMERICAN INLINE HOCKEY CLUB CHAMPIONSHIP will be held in the city of Ibagué from AUGUST 7th TO AUGUST 18th, 2024.

ART. 3º. - ORGANIZATION, the World Skate America and the Colombian Skating Federation will lead the organization of the event in administrative and logistical aspects, the Technical Committee of Inline Hockey of the WORLD SKATE AMERICA will be in charge of the technical sports aspects and will have the support of the Tolima Skating League.

ART. 4º. PARTICIPANTS. - The Inline Hockey clubs of the nations affiliated to WORLD SKATE that are part of the American continent may participate in this competition.

PARAGRAPH 1º. PLAYERS: All the players of the PAN AMERICAN CHAMPIONSHIP OF INLINE HOCKEY CLUBS 2024 must prove their nationality and age in the different categories by means of their respective Passport and through their respective delegates.

ART. 5. REGISTRATION. - For the club event, each country will be able to register all the teams interested in participating in each of the categories and branches of the tournament, the clubs of each region that wish to participate, must send an email with their intention to participate with their different categories, including the data of the team delegate, contact telephone, date of birth and email to registroih@worldskateamerica.org , once the email is received links will be sent to start the Team Roster entry process.

PARAGRAPH 1. The price of ON TIME registrations, as stipulated by WORLD SKATE AMERICA, will be as follows:

PARAGRAPH 2. The registration fee shall be paid in person and in cash at the facilities provided by WORLD SKATE AMERICA for accreditation and briefing.

ART. 6º. CATEGORY AWARDS, WORLD SKATE AMERICA will have the following awards for the Championship, which will be given at the end of the Championship:

CATEGORY U12, U14, U16 and WOMEN's OPEN AND MEN's OPEN:

- ✓ Gold, silver and bronze medals for 1st, 2nd and 3rd Place.
- ✓ Trophies for champion, runner-up and third place club.
- ✓ Caps for the champion team.
- ✓ Plaques and cap for Best Player and Least Defeated Goal.

U8 and U10 CATEGORY

- ✓ Gold medals for all participants.
- ✓ Trophies for champion and runner-up clubs.
- ✓ Caps for the champion team.

ART. 7º. PROTESTS AND CLAIMS, Any protest or claim must be presented in first instance in writing by the respective delegate of the claimant team, complying with the established in the regulations of the WORLD SKATE modality, and particularly for this event with up to one hour after the end of the match object of the claim, The protest must be signed by the delegate of the team/federation who is duly accredited and accompanied by payment of USD \$350.00 to the members of the Sport Tribunal of the tournament. If the result is adverse to the claimant, he/she may file an appeal or protest before the technical committee of the WORLD SKATE AMERICA (maximum one hour after the decision of the judges) signed by the delegate of the team/federation who is duly accredited and accompanied by payment of USD\$600.00 Each sum must be deposited to the World Skate America delegate in charge of the competition; in case of a decision in favor of the claimant, the sum will be returned; otherwise it will be credited to the World Skate America account within 48 hours after the end of the event.

ART. 8º - AUTHORITIES OF THE EVENT

- ✓ Authorities of the event will be the Pan American Inline Hockey Technical Commission.
 - Mr. Eduardo Rojas CHAIRMAN CTHL W.S.A.
 - Mr. Francisco Carreño MEMBER CTHL W.S.A.

- ✓ The ultimate judging authority will be the referee judges appointed by World Skate America.

- ✓ The highest disciplinary authority shall be the Disciplinary Commission of the event, which shall be composed of one (1) member of World Skate America, one (1) Member of the Judging, one (1) Member of the organizing federation.

ART. 9° - DESIGNATION OF REFEREES. The referees of the PAN AMERICAN LINE HOCKEY CLUB CHAMPIONSHIP 2024 shall be appointed by the CTHP-WSA.

ART. 10° - ADMINISTRATIVE OBLIGATIONS. - The administrative and financial obligations for the development of the event will be agreed between the President of WORLD SKATE AMERICA and the President of the host Federation, in such a way as to guarantee all the services, and an adequate organization of the event in the technical, logistic, judging, safety and health aspects for the participants, the media and the spectators.

PARAGRAPH: Only the Inline Hockey Technical Committee of the WORLD SKATE AMERICA may modify match schedules for the general benefit of the development of the event.

ART. 11°- INAUGURAL INFORMATION MEETING. - The informative meeting of the event will be held in the place and time that the organization of the event will provide for that purpose and that will be announced in follow up bulletins. For this meeting, the presence of all the delegates registered in the respective forms is requested.

ART. 12°.- ACCIDENT INSURANCE World Skate America is not responsible for accidents that may occur during the event, for which reason all athletes, technicians, delegates and judges must have valid medical and accident insurance, documents that must be presented at the time of registration.

ART. 13° RESPONSIBILITY IN ACCIDENTS. - WORLD SKATE AMERICA and the COLOMBIAN SKATING FEDERATION are not responsible for accidents that may occur during the event, for which reason all athletes and members of the coaching staff must have and prove a valid medical and/or accident insurance, which in the case of foreign countries to Colombia, must be of International Assistance that includes coverage in sports issues, ORIGINAL documents that must be presented at the time of the respective accreditations.

ART 14°.- DISCIPLINARY PENALTIES All disciplinary cases that arise in the event will be evaluated according to their seriousness and will be referred in the first instance to the disciplinary committee of the event and if warranted will be transferred to the disciplinary committee of World Skate America to initiate the respective disciplinary process.

ART. 15° UNFORSEEN CASES: The cases not foreseen in the present resolution, will be resolved by World Skate America in accordance with the unique regulations of this discipline published on the institution's web page.
