

RESOLUTION No. 005 April 02, 2024

By means of which **the PAN AMERICAN FESTIVAL OF ARTISTIC SKATING CATEGORY ROOKIES 2024** is convened and regulated, to be held in the city of Ibagué (Colombia), from July 22 to 27, 2024.

The president of World Skate America in use of his legal and statutory powers and;

CONSIDERING

• That the 2024 Pan American Calendar provides for the holding of the 2024 PAN AMERICAN ARTISTIC SKATING FESTIVAL ROOKIE CATEGORY.

• That it is the duty of World Skate America to regulate all events on the official calendar of all forms of skating.

• That it is the duty of World Skate America to promote the development and massification of the discipline of artistic skating on the American continent.

SOLVE

ARTICLE 1 ° CALL

Call and regulate, as is actually done, the PAN AMERICAN FESTIVAL OF ARTISTIC SKATING CATEGORY ROOKIES 2024 .

PARAGRAPH 1 ° - No athlete can register in two different categories or efficiencies, that is, each athlete may only have one participation per modality.

PARAGRAPH 2° - Athletes who participate in the Pan American Championship of promotional clubs cannot participate in this tournament.

ARTICLE 2 ° - CATEGORIES, MODALITIES, LEVELS

PARAGRAPH 1 ° - CATEGORIES: Depending on age, you may compete in the following categories and may advance, but never compete in a lower category. To be eligible to compete in any category, a skater who has previously competed in a higher category in any event may not compete in a lower one.

Note: The AGE column in the table refers to the age at which the skater is turning in the year of the competition (i.e., the age they will be on December 31 of the year of the competition).

SENIOR category is defined as the grouping of the Cadet, Youth, Junior and Senior categories. If deemed appropriate, the WSA ATC could separate the Senior category into individual events following the WS categories for the different ages, that is, Cadet, Youth, Junior and Senior.

PARAGRAPH 2 ° - MODALITIES: the competition will be in the free and compulsory figures modalities.

PARAGRAPH 3° - In the mandatory figures modality, there will be competition in a single efficiency for all categories. The figures that will be competed with will be 1 and 1SB and there will be two runs of each one.

PARAGRAPH 4 ° - For the freestyle modality, you can compete in three different efficiencies. In this club event, competition will be carried out with the technical regulations contemplated in the World Skate America Artistic 2024 regulations for rookies, to be published on the website.

ARTICLE 3 ° HEADQUARTERS AND DATES

The event will take place at the **Coliseum Mayor of the Ibagué Sports Park, Colombia** located on the Perales Airport Road.

The Dates will be from July 22 to 27, 2024 with the following schedule (These dates may change one day, before or after, the stipulated dates depending on the number of registered):

ARTICLE 4 ° ORGANIZATION

World Skate America will coordinate the organization of the event with the support of the Colombian Skating Federation in administrative and logistical aspects, and the technical committee of artistic skating in the technical sports aspects.

ARTICLE 5 ° PARTICIPANTS

Athletes from clubs, schools, teams or associations from countries whose National Federations are part of WSA may participate in the event.

ARTICLE 6 ° REGISTRATION LIMIT

Athletes: There is no restriction on the number of athletes registered by category, efficiency and branch.

Coaches: Each club, school, team or association will have the right to register up to two (2) coaches plus one (1) delegate. Extra coaches and/or delegates may register at a cost.

ARTICLE 7 ° SANCTIONS AND TRANSITIONAL DISABILITY

The Club, association, team or school that registers athletes, who do not appear at the event or who, being registered, do not appear for a specific test, will be sanctioned or disqualified as stipulated by the WSA. Payment of the penalty is essential for the club/federation to regain the right to participate in another competition.

PARAGRAPH 1 ° - Athletes, clubs, associations, teams or schools who:

• Present justification accredited by an official doctor verified by the Federation to which they belong.

• For reasons of force majeure, duly verified by the WSA artistic skating technical commission and authorized by the president of the WSA.

PARAGRAPH 2 ° - In the event that a non-athletic organization is exempt from the established disabilities, it is not exonerated from the payment of the financial obligations acquired with the organization and the WSA, corresponding to the athlete's registrations and /or club/federation to the event, as the case may be.

PARAGRAPH 3 ° - Athletes and/or clubs that incur any of the disabilities described in this article will have three (3) calendar days following the event, to present by written the reasons they had to justify their non-attendance at the event, with the respective evidence to the email <u>inscripcionesartistico@worldskateamerica.org</u>

ARTICLE 8 ° AWARD

will be awarded as follows: 1 gold, 2 silver and 2 bronze.

ARTICLE 9 ° DRAWINGS AND STARTING ORDERS

The exit orders will be made electronically and will be published in advance for review and correction prior to the briefing.

ARTICLE 10 ° REGISTRATIONS AND ENDORSEMENTS

Club registrations must be submitted individually by each club, school, team or association. The registration must be sent according to the dates established in this article by email to <u>inscripcionesartistico@worldskateamerica.org</u> The template published on the World Skate America page must be used, without converting to PDF or image.

Different formats will not be taken into account.

PARAGRAPH 1 ° - The ORIGINAL form, duly signed by the club, must be presented on the day of accreditations. Without this document, accreditation cannot be carried out. Incomplete registrations submitted in a different format will be considered not received.

PARAGRAPH 2° - For the novice clubs event, we will notify you later if it will be necessary to upload a form to a cloud folder. For this purpose, a folder will be shared later.

PARAGRAPH 3 ° - The music of the athletes MUST BE uploaded according to the modality to be published. It must be recorded at 320 and in MP3 format. The name of each file must be: skater name_skater last name_efficiency_category .

PARAGRAPH 4 ° - The club, school, team or association that is not represented at the information meeting, by its delegate duly accredited to the WSA, will not be able to make claims at the event.

ARTICLE 11 ° REGISTRATION VALUE

The value of ordinary and extraordinary registrations will be:

PARAGRAPH 1 ° - The value of the Championship registrations must be paid in cash in American dollars, by the respective delegate before entering the event briefing meeting (according to detailed programming to be published later).

ARTICLE 12 ° CLAIMS

The rules of Word Skate will be followed.

ARTICLE 13 ° EVENT AUTHORITIES

• The highest authority in the technical direction of the event will be the person designated by the president of World Skate America.

• The highest judging authority will be the technical officials.

• The highest disciplinary authority will be the Disciplinary Commission of the event, which will be made up of the referee of the event, one of the delegates of the Pan American commission present and a representative designated by the Headquarters Federation. of the event.

• The maximum administrative authority will be the Steering Committee of the event, headed by the president of World Skate America.

ARTICLE 14 ° CANCELLATION OR MODIFICATION OF TESTS

Only the figure skating technical committee of World Skate America may modify or cancel a certain event that does not conform to the conditions of the competition, due to space on the stage, lack of time, competitive level, guarantees or for unforeseen delays in programming.

ARTICLE 15 ° INFORMATIVE MEETING

The information meeting of the event will take place on July 22, 2024 at the place and time that the organization of the event has for this purpose and that will be announced in the official invitation.

For this meeting, the presence of at least one of the coaches per club who are registered on the respective rosters and the judges who have been summoned is requested.

PARAGRAPH 1 ° - Once the information meeting is concluded, the judges ' meeting will be held in the same room.

ARTICLE 16 ° RESPONSIBILITY IN ACCIDENTS

World Skate America and the Colombian Skating Federation are not responsible for accidents that may occur during the event, which is why all skaters must have current medical and/or accident insurance, ORIGINAL documents. which must be presented at the time of the respective accreditations.

ARTICLE 17 ° VALIDITY

This resolution takes effect from the date of its issuance. Given in the city of Ibagué, on the 2° day of April 2024.
