By means of which the **PAN AMERICAN INLINE HOCKEY NATIONS CHAMPIONSHIP 2024** is summoned and regulated, to be held in the city of IBAGUE from **August 01 to 07, 2024**.

The President of WORLD SKATE AMERICA WSA and the PAN AMERICAN INLINE HOCKEY COMMISSION in use of their Legal and Statutory attributions and:

CONSIDERING:

- That WORLD SKATE AMERICA contemplates in its continental calendar 2024, the Pan American championship of Inline Hockey **Nations** in the categories Senior Women, Senior Men, Junior Women and Junior Men.
- That it is the duty of WORLD SKATE AMERICA to regulate the practice of inline hockey for all its official Pan American events and which will be responsible for organizing the Pan American championships of nations.

TERMS:

ART. 1º. - To summon all the national teams of the Pan American area to participate in the **PAN AMERICAN CHAMPIONSHIP OF NATIONS INLINE HOCKEY**, to be held in the city of Ibagué, for the categories: **SENIOR WOMEN, SENIOR MEN, JUNIOR WOMEN and JUNIOR MEN during the days 01 to 07 AUGUST 2024**.

PARAGRAPH 1. CATEGORIES AND AGES, the PAN AMERICAN NATIONS LINE HOCKEY CHAMPIONSHIP 2024 will be held in the following categories and in the following manner:

- **Senior Women:** Athletes born in the year 2010 and earlier
- **Senior Men :** Athletes born in the year 2008 and earlier
- **Junior Women:** Athletes born in years **2005-2006-2007-2007- 2008-2009-2010**.
- **Junior Men:** Athletes born in years **2005-2006-2007- 2008-2009-2010**.

PARAGRAPH 2. 2005 Birth year will be allowed to participate in the junior categories ONLY for this 2024 PAN AMERICAN NATIONS CHAMPIONSHIPS.

ART. 2º. - **CITIES AND DATES**, the **PAN AMERICAN CHAMPIONSHIP OF NATIONS INLINE HOCKEY**, will be held in the city of Ibagué, for the categories: SENIOR WOMEN, SENIOR MEN, JUNIOR WOMEN and JUNIOR MEN during the days 01 to 07 AUGUST 2024.

ART. 3º. - **ORGANIZATION**, the World Skate America and the Colombian Skating Federation will lead the organization of the event in administrative and logistical aspects, the Technical Committee of Inline Hockey of the WORLD SKATE AMERICA will be in charge of the technical sports aspects and will have the support of the Tolima Skating League.

ART. 4º. PARTICIPANTS. - The different National Men's and Women's Inline Hockey Teams of Nations affiliated to WORLD SKATE that are part of the American continent, with the endorsement of their respective national federation, may participate in this competition of Nations.

PARAGRAPH 1º. NATIONAL PLAYERS: All players of the PAN AMERICAN CHAMPIONSHIP OF INLINE HOCKEY NATIONS 2024 must prove the nationality of the country they represent by means of the respective Passport and through their respective delegates.

ART. 5º. REGISTRATIONS. - For the Nations event, each country may be present with only one team in each of the categories and branches of the tournament. The participating national teams must send an email with their intention to participate with their different categories, team delegate Name, team delegate telephone, date of birth and email to registroi@worldskateamerica.org once the email is received, links will be sent to start the Team Roster Entry process of their players.

A follow up email will be sent with Detailed Instructions.

PARAGRAPH 1. The Price of ON TIME Registrations, as stipulated by WORLD SKATE AMERICA, shall be as follows:

PARAGRAPH 2. The registration fee shall be paid in person and in cash at the facilities provided by WORLD SKATE AMERICA for accreditation and briefing.

ART. 6º. CATEGORY AWARDS, WORLD SKATE AMERICA will have the following awards for the Championship, which will be given at the end of the Championship:

JUNIOR WOMEN AND MEN:

- ✓ Gold, silver and bronze medals for 1st, 2nd and 3rd Place.
- ✓ Trophies for champion, runner-up and third place
- ✓ Caps for the champion team
- ✓ Plaques and cap for Best Player and Best Goalie.

SENIOR WOMEN AND MEN:

- ✓ Gold, silver and bronze medals for 1st, 2nd and 3rd Place.
- ✓ Trophies for the champion, runner-up and third place
- ✓ Caps for the champion team
- ✓ Plaques and cap for Best Player and Least Defeated Goal.

ART. 7º. PROTESTS AND CLAIMS, Any protest or claim must be presented in first instance in writing by the respective delegate of the claimant team, complying with the established in the regulations of the WORLD SKATE modality, and particularly for this event with up to one hour after the end of the match object of the claim, The protest must be signed by the delegate of the team/federation who is duly accredited and accompanied by payment of USD \$350 to the members of the Sport Tribunal of the tournament. If the result is adverse to the claimant, he/she may file an appeal or protest before the technical committee of the WORLD SKATE AMERICA (maximum one hour after the decision of the judges) signed by the delegate of the team/federation who is duly accredited and accompanied by payment of USD \$600. Each sum must be deposited to the World Skate America delegate in charge of the competition; in case of a decision in favor of the claimant, the sum will be returned; otherwise it will be credited to the World Skate America account within 48 hours after the end of the event.

ART. 8º - AUTHORITIES OF THE EVENT ✓ The maximum authority of the event will be the members of the Pan American Inline Hockey Technical Commission appointed for the event
- Mr. Eduardo Rojas CHAIRMAN CTHL W.S.A.
- Mr. Francisco Carreño MEMBER CTHL W.S.A.

- ✓ The highest judging authority will be the referee judges appointed by World Skate America.
- ✓ The highest disciplinary authority shall be the Disciplinary Commission of the event, which shall be composed of one (1) member of World Skate America, one (1) Member of the Judging, one (1) Member of the organizing federation.

ART. 9º - DESIGNATION OF REFEREES. The referees of the PAN AMERICAN NATIONS INLINE HOCKEY CHAMPIONSHIP 2024 shall be appointed by the CTHP-WSA.

ART. 10 - ADMINISTRATIVE OBLIGATIONS. - The administrative and financial obligations for the development of the event will be agreed between the President of WORLD SKATE AMERICA and the President of the host Federation, in such a way that all the services are guaranteed, and an adequate organization of the event in the technical, logistic, judging, security and health aspects for the participants, the media and the spectators.

PARAGRAPH: Only the Inline Hockey Technical Committee of the WORLD SKATE AMERICA will be able to modify match schedules, for the general benefit of the development of the event.

ART. 11- INAUGURAL INFORMATION MEETING. - The informative meeting of the event will be held at the place and time that the organization of the event will provide for such purpose and that will be announced in the official invitation bulletins. For this meeting, the presence of all the delegates registered in the respective forms is requested.

ART. 12º.- ACCIDENT INSURANCE World Skate America is not responsible for accidents that may occur during the event, which is why all athletes, technicians, delegates and judges must have valid medical and accident insurance, documents that must be presented at the time of registration.

ART. 13º RESPONSIBILITY FOR ACCIDENTS. - WORLD SKATE AMERICA and the COLOMBIAN SKATING FEDERATION are not responsible for accidents that may occur during the event, reason why all athletes and members of the coaching staff must have and prove a valid medical and/or accident insurance, which in the case of foreign countries to Colombia, must be of International Assistance that includes coverage in sports issues, ORIGINAL documents that must be presented at the time of the respective accreditations.

ART. DISCIPLINARY PENALTIES All disciplinary cases that arise in the event will be evaluated according to their seriousness and will be referred in the first instance to the disciplinary committee of the event and if warranted will be transferred to the disciplinary committee of World Skate America to initiate the respective disciplinary process.

ART. 15º UNFORESEEN SITUATIONS: The cases not foreseen in the present resolution, will be resolved by World Skate America in accordance with the unique regulations of this discipline published on the institution's web page.

ART. 16º. - This resolution is effective from the date of its issuance. Given on the third (3rd) day of the month of APRIL (2024).
