

RESOLUTION No.015 July 21, 2025

The 2025 Pan American Club Inline Hockey Championship is scheduled to take place in Mexico City from **October 1 to 13, 2025**, as announced and regulated by the relevant authorities.

The president of **WORLD SKATE AMERICA (WSA)** and the **Pan American Inline Hockey Commission**, exercising their legal and statutory powers, and:

CONSIDERING:

- That WORLD SKATE AMERICA includes the 2025 Pan American Club Championship in its official continental calendar. Official Divisions are: U8, U10, U12, U14, U16, WOMENS OPEN, MENS OPEN, WOMENS MASTERS and MENS MASTERS.
- That it is WORLD SKATE AMERICA's responsibility to regulate inline hockey across its official Pan American events and to organize the Pan American Nations Championships.

ARTICLE SUMMARIES

Article 1 - Call to Clubs

All Pan American clubs are invited to participate in the WSA Panamerican Club Championships. Categories are:

SUB 8, SUB 10, SUB 12, SUB 14, SUB 16 (Girls & Boys), OPEN (Women & Men), MASTER (Women & Men)

Competition Schedule:

- Oct 1–6: U8, U10, U12, U14
- Oct 6–13: U16 MEN & WOMEN, MEN & WOMEN OPEN, MENS & WOMEN MASTER's

Article 3 – Event Organization

Led by WORLD SKATE AMERICA and the **Mexican Roller Sports Federation**. Technical aspects will be handled by WSA's Inline Hockey Technical Committee.

Article 4 - Who Can Participate

Only clubs from WSA-affiliated nations in the Americas.

Players must present passport and age verification at the technical meeting.

Article 5 - Registration

Article 6 – Awards U8 & U10:

- Gold medals for all participants.
- Champion & runner-up trophies.
- Caps for winners.

U12, U14, U16, WOMENS OPEN, MENS OPEN, WOMENS MASTER and MENS MASTER:

- Gold, Silver, Bronze medals.
- Champion, runner-up, third-place trophies.
- MVP & Best Goalie plaques and caps.

Article 7 - Protests

Written protests are allowed within 1-hour post-match, signed by team delegate. Properly accredited.

- First-level protest: USD \$350
- Appeal: USD \$600

Refund if protest is accepted; otherwise, funds go to WSA 48 hours after event has concluded.



Article 8 – Event Authorities

Highest Authority: President of WSA

- Referees & Discipline: Appointed by WSA

Article 9 – Referee Appointment

Referees designated by CTHL-WSA, approved by WSA President.

Article 10 – Administrative Duties

Agreements made between WSA President & host federation president to ensure proper services and logistics.

Article 11 - Information Meeting

Details to be announced in the official invitation. All team delegates must attend.

Articles 12-13 - Accident & Insurance

WSA and the Mexican federation **are not responsible for accidents**. All participants must have valid accident and medical insurance. Foreign participants must provide **international coverage** for sports-related risks.

Article 14 - Disciplinary Action

All disciplinary matters will be handled by the event commission. Serious cases may escalate to WSA's disciplinary committee.

Article 15 – Unforeseen Cases

Will be resolved by WSA according to the official discipline rules on their website.

Article 16 - Effective Date

This resolution is effective as of its publication date in July 21, 2025.
