

RESOLUTION No. 016 July 21, 2025

The Pan American Nations Inline Hockey Championship 2025 is scheduled to take place in Mexico City from October 13 to 19, 2025, as announced and regulated by the relevant authorities.

The president of WORLD SKATE AMERICA (WSA) and the **PAN AMERICAN INLINE HOCKEY COMMISSION**, exercising their legal and statutory authority, and:

CONSIDERATIONS

- World Skate America includes this championship in its official 2025 continental calendar with the following divisions being offered: Senior Women, Senior Men, Junior Women and Junior Men.
- It is the duty of World Skate America to regulate the sport of inline hockey for all its official Pan American events, and to oversee the organization of the Pan American Nations championships.

ARTICLE 1 – Call to Participation

All Pan American national teams are invited to compete in the following divisions:

- **Senior Women**: Athletes born in 2006 or earlier
- **Senior Men**: Athletes born in 2006 or earlier
- Junior Women: Athletes born between 2006 and 2011
- Junior Men: Athletes born between 2006 and 2011

ARTICLE 2 – Host City and Event Dates

The Championship will take place in **Mexico City**, from **October 13 to 19, 2025**, for all categories listed above.

ARTICLE 3 – Organization

The event will be jointly organized by **World Skate America** and the **Mexican Roller Sports Federation**. Technical and athletic aspects will be overseen by the **Pan American Inline Hockey Technical Commission of WSA**.



ARTICLE 4 – Eligibility

Eligible teams include men's and women's **national teams** from WSA-affiliated countries in the Americas, with endorsement from their respective national federations.

All athletes must present a valid **passport** confirming their nationality at the **technical meeting on October 13**.

ARTICLE 5 – Registration

Each country may register one team per division.

To register, national teams must submit an email to registroih@worldskateamerica.org including:

- Categories of participation
- Team delegate name
- Contact phone number
- Date of birth
- Email address

Upon receipt, WSA will reply with registration links for player enrollment.

Deadlines:

Regular registration: August 31, 2025Late registration: September 6, 2025

Fees are payable in cash during team accreditation.

After team registration, WSA will issue an official statement confirming the categories in play, group allocations, and match format.



ARTICLE 6 – Awards by Category

Junior Women & Men

- Gold, silver, and bronze medals for 1st, 2nd, and 3rd place
- Trophies for champion, runner-up, and third place
- Champion team caps
- Plagues and caps for MVP and Best Goaltender

Senior Women & Men

(Identical awards structure)

ARTICLE 7 – Complaints & Appeals

Written complaints must be filed within **one hour** after the match in question, signed by the accredited team delegate.

- First-level protest: USD \$350
- Appeal to WSA Technical Committee: USD \$600

If the claim is accepted, the fee is refunded; otherwise, it is retained by WSA. Decisions will be communicated within **48 hours** post-event.

ARTICLE 8 – Event Authorities

- Highest Authority: President of World Skate America
- Technical Commission Members:
 - Eduardo Rojas Chairman, CTHL WSA
 - o Charles Sgrillo WSA IHTC Member
 - o Francisco Carreño- WSA IHTC Member
- Referees: Appointed by WSA
- **Disciplinary Authority**: Commission composed of one WSA member, one judging member, and one host federation representative



ARTICLE 9 – Referee Appointments

Referees will be designated by the CTHL-WORLD SKATE AMERICA, upon approval of the President.

ARTICLE 10 – Administrative Obligations

Logistical and financial responsibilities will be coordinated between WSA and the host federation to ensure all services, safety, and technical excellence.

The Technical Committee reserves the right to adjust match schedules for operational efficiency.

ARTICLE 11 – Informational Meeting

To be held at the time and place designated in the official invitation. Attendance by all registered team delegates is mandatory.

ARTICLES 12–13 – Insurance Requirements

World Skate America and the Mexican Federation disclaim liability for any accidents. All athletes, coaches, delegates, and referees must have active **medical and accident insurance**, verifiable during registration.

International teams must present **original documents** showing coverage for sports-related incidents, valid in Mexico.

ARTICLE 14 - Disciplinary Actions

Incidents will be reviewed by the event disciplinary commission. Severe violations may be referred to the WSA Disciplinary Committee for formal proceedings.

ARTICLE 15 – Unforeseen Cases

Any issues not addressed herein will be resolved by World Skate America under the unified rules published on its official website.



ARTICLE 16 – Effective Date

This resolution becomes effective from its date of issuance: July 21, 2025
