

# RESOLUTION N° 017 JULY 21ST, 2025

By means of which the **2025 PAN AMERICAN RINK HOCKEY CLUBS CHAMPIONSHIP** in the Under-19 Men's, Under-19 Women's, Senior Men's, and Senior Women's categories, to be held in the city of San Juan, Argentina, from November 9th to 15th, 2025.

The President of World Skate America WSA, in use of his legal and statutory authority;

#### **CONSIDERING:**

That World Skate has regulated and stipulated that the teams and CLUBS that will participate in the 2026 World Club Championship must be defined in the respective continental Club championship in the Senior Women's and Senior Men's categories, in this case the 2025 PAN AMERICAN CLUB RINK HOCKEY CHAMPIONSHIP, a rule that applies to the SENIOR MEN'S and SENIOR WOMEN'S categories.

World Skate America and its Technical Committee for Rink Hockey, after analyzing the Rink hockey processes in the different regulated categories, has decided to convene the Under 19 Women's, Under 19 Men's, Senior Women's and Senior Men's categories to the 2025 PAN AMERICAN CLUB RINK HOCKEY CHAMPIONSHIP.

It is the duty of World Skate America to regulate all events on the official calendar for all skating disciplines.

## **SOLVE:**

**ART. 1º. ANNOUNCEMENT.** - To convene and regulate, as is hereby done, the PAN-AMERICAN CLUB RINK HOCKEY CHAMPIONSHIP in the categories UNDER 19 FEMALE, UNDER 19 MALE, SENIOR FEMALE AND SENIOR MALE, to be held in the city of San Juan, Argentina, from November 2nd to 8th, 2025.

**PARAGRAPH 1. – CATEGORIES:** The 2025 Pan American Rink Hockey Club Championship will be held in the following categories and in the following manner:

### **CATEGORIES FEMALE DIVISION**

**Under-19 Women:** Female athletes who are at least 14 years old and up to 18 years old as of December 31, 2025.

**SENIOR LADIES:** Female athletes aged 14 or older, as of the first day of the championship.

#### **CATEGORIES MEN'S DIVISION**

**Under-19 Men:** Male athletes who are at least 14 years old and up to 18 years old as of December 31, 2025.

MEN'S SENIOR: Male athletes who are 14 years or older, as of the first day of the championship.

In this event, competition will be conducted in accordance with the technical regulations set forth in the specific rules of the Championship.

PARAGRAPH 2. QUALIFICATION AND ENDORSEMENT FOR THE CLUB WORLD CHAMPIONSHIP: The Pan American Club Rink Hockey Championship is the continental club event that will qualify and endorse the Champion and Runner-up teams in the Senior Women's and Senior Men's categories for the respective World Club Championship, according to World Skate regulations.

**Art. 2nd. CITY AND DATES** – The 2025 PAN AMERICAN RINK HOCKEY CLUB CHAMPIONSHIP in the Under 19 and Senior categories, both men's and women's divisions, will be held in the city of San Juan, Argentina, from November 2nd to 8th, 2025.

**Art. 3rd. ORGANIZATION.** - World Skate America, as the governing body of Rink hockey on the continent, has entrusted the Argentine Skating Confederation with the responsibility of organizing the event. The C.A.P. delegates to the Government of San Juan the organization to attend to the administrative, logistical, operational, and infrastructural aspects in coordination with the authorities of the San Juan Skating Federation; always under the administration, support, and supervision of the Technical Committee of Rink Hockey of the WSA (WSA-RHTC) in the necessary technical-sports aspects.

**Art. 4th. PARTICIPANTS.** - The different Men's and Women's Rink Hockey teams may participate in this CLUB competition, provided they are affiliated and present proof of registration from their respective national federation affiliated with WSA; without this proof of registration, no Club or Team will be accepted.

**PARAGRAPH 1. ACCREDITED PLAYERS:** All players in the 2025 PAN AMERICAN RINK HOCKEY CLUB CHAMPIONSHIP in the Under 19 Women's and Men's, Senior Women's and Men's categories must prove their sports registration with the CLUB they represent through the corresponding endorsement of their Federation or Sports Confederation.

**PARAGRAPH 2. REINFORCEMENTS:** Teams will be allowed to register reinforcements (athletes who play for other clubs in the same national federation or from another country), with prior written

authorization from the club where they play and endorsed by the governing body of said club (respective Confederation or Federation).

Clubs from the confederation and/or federations of Argentina and Chile may have up to one (1) reinforcement in each category and in both branches.

For the remaining national federations, a maximum of two (2) reinforcements will be allowed in each category and in both branches.

In the case of an international transfer, payments and administrative supporting documents must be submitted prior to the championship, at the time of submission of the final List of Good Faith.

The rates applied for the payment of reinforcements are \$250 Dollars per reinforcement in both Categories and Branches.

**Art. 5th** - **REGISTRATION.** – For the Pan American Club Championship, registrations and places per category will be:

- **Senior Men**, Argentina: 15 places. It should be noted that WSA agreed with the organizer (San Juan Government) on 8 places for that Federation remaining places to be distributed by the CAP –; Chile: four places plus the champion of the 2024 edition; Colombia: three places. Five places will be available for the Federations of Uruguay, the U.S., Mexico, and Brazil.
- Women's Senior: Argentina has 10 places; it should be noted that WSA agreed with the San Juan Government Organizer on 5 places remaining places to be distributed by the CAP plus the Champion of the 2024 edition, Chile 4 places, Colombia 3 places. Uruguay, Brazil, the USA, and Mexico will each have 4 places available.
- Under 19 Men's: Argentina has 9 places; it should be noted that the San Juan Federation has 5 places the remaining places are to be distributed by the CAP –; Chile has 4 places; Colombia has 3 places. The Federations of Uruguay, Brazil, the U.S., and Mexico have 4 places available.
- Under-19 Women's: Argentina has 6 places, three of which belong to the San Juan Skating Federation the remaining places to be distributed by the CAP –; Chile has 3 places; Colombia has 2 places. For Uruguay, Brazil, USA and Mexico: 4 Places.

**PARAGRAPH 1.** The Technical Committee of World Skate America, once the extraordinary registration dates have closed, may allocate the places from the quotas assigned to the different National Federations that did not meet their registration quota, to extend registration invitations to clubs that

have expressed their intention to participate in the Pan American Club Championship.

Registrations will ONLY be accepted using the official WORLD SKATE AMERICA form for Rink Hockey championships. This form must be completed (names, jersey numbers, date of birth, card number or license of each federation) on a computer and sent via e-mail only by the Federations to the mails <a href="mailto:cthp@wordlskateamerica.org">cthp@wordlskateamerica.org</a> and <a href="mailto:danielmartinazzo.worldskate.org">danielmartinazzo.worldskate.org</a>.

ORDINARY registrations will be accepted until August 31, 2025, and EXTRAORDINARY registrations until September 15, 2025.

The fees and amounts for team registration are those stipulated by WORLD SKATE AMERICA in its fee schedule as follows, and always in USD (United States Dollars):

The registration fee must be paid in cash exclusively to the administrative officials designated by the president of WSA, at the facilities provided by WORLD SKATE AMERICA for accreditation and the information meeting.

### **PARAGRAPH 2. TIMELINE OF DATES**

- 30/7/2025 Official Communication of the Regulations.
- 08/31/2025 Closing Date for Regular Registrations.
- 09/15/2025 Closing Date for Extraordinary Registrations.
- 25/9/2025 Closing date and definition of teams and quotas.
- 10/15/2025 First submission of all documentation (Good Faith List, Number of Players, Jersey Colors, Documents, registration payments, etc.)
- Regarding the players, all those considered by the Federation can be included, and regarding reinforcement transfers, they must be on the final list to be submitted.
- 09/19/2025 Zone Draw.
- 10/20/2025 Closing date for final good faith lists.

**Art. 6th. - AWARDS.** WORLD SKATE AMERICA will have the following awards for the Championship, which will be presented at its conclusion:



- To the Pan American Champion, a Trophy plus 16 Gold Medals.
- To the Pan American Runner-up, 16 Silver medals.
- Third Place in the Pan American Games, 16 Bronze Medals.

**Art. 7th - PROTESTS AND COMPLAINTS. -** Any protest or claim must be submitted in the first instance in writing by the respective delegate of the claiming team, complying with the regulations of the WORLD SKATE modality, and particularly for this event, within a maximum of one hour after the end of the match subject to the claim. The protest must be signed by the duly accredited team/club delegate and accompanied by US\$350 to the members of the tournament's Sports Tribunal.

If the result is averse to the claimant, they may file an appeal or protest with the technical committee of WORLD SKATE AMERICA (no later than one hour after the judges' decision is issued), signed by the duly accredited team/federation delegate and accompanied by US\$600.

Each sum must be deposited with the World Skate America delegate in charge of the event; if the ruling is in favor of the claimant, said sum will be returned to them; otherwise, it will be paid into the World Skate America account within 48 hours of the event's conclusion.

#### ART. 8º - AUTORIDADES DEL EVENTO.

- The highest authority of the event is the president of WSA.
- Regarding the technical management of the event, the delegates from the Technical Commission of WORLD SKATE AMERICA are:
- Mr. Daniel Martinazo, Director CTHP-WSA Argentina.
- Mr. Ricardo Suárez, CTHP-WSA Member Colombia
- Mr. Juan Zúñiga, Member of CTHP-WSA Chile.
- The highest disciplinary authority will be the event's Disciplinary Tribunal. It will be made up of a member of the WORLD SKATE AMERICA Technical Committee, the designated referee coordinator (whether this is an international referee or a member of the Technical Committee), and a representative designated by the Host Federation of the event.
- The highest administrative authority will be the event's Steering Committee, headed by the President of WORLD SKATE AMERICA.



**Art. 9th - ARBITRAL APPOINTMENT.** The referees for the 2025 Pan American Rink Hockey Nations Championship will be appointed by the CTHP-WSA, must be of "International Category" and be up to date with their World Skate fees.

If the WSA-RHTC deems it necessary, it may appoint National Federation Referees where the Championship is held.

**Art. 10th - ADMINISTRATIVE OBLIGATIONS.** – The administrative and financial obligations for the development of the event will be agreed upon between the President of WORLD SKATE AMERICA and the Government of San Juan, in such a way as to guarantee all services and the proper organization of the event in the technical, logistical, judging, security, and health aspects for participants, the media, and spectators.

**PARAGRAPH.** Only the Technical Committee of Rink Hockey of WORLD SKATE AMERICA may modify match schedules, for the overall benefit of the event's development.

PARAGRAPH 2. INTERNAL TRANSPORTATION AND ACCOMMODATION FOR DELEGATIONS DURING THE PAN AMERICAN CLUB CHAMPIONSHIP. Internal expenses for each delegation during the 2025 Pan American Club Championship, such as lodging, food, internal transportation, etc., will be the sole responsibility of each participating delegation.

**Art. 11th - INFORMATIVE MEETING. -** The event briefing will be held at the time and place designated by the event organizers, which will be announced in the official invitation. The presence of all delegates registered on the respective lists is requested for this meeting.



**Art. 12th LIABILITY IN ACCIDENTS.** - WORLD SKATE AMERICA, the Argentine Skating Confederation, the San Juan Skating Federation, and the Government of San Juan are not responsible for any accidents that may occur during the event. Therefore, all athletes, coaching staff, and officials must have and provide proof of valid medical and/or accident insurance.

Athletes and coaching staff, in addition to accident and health insurance, must provide proof of a valid NON-RECURRENCE INSURANCE policy in favor of World Skate America, the San Juan Skating Federation, the Argentine Skating Confederation, and the Government of San Juan.

**Art. 13th EFFECTIVE DATE. -** This resolution is effective from the date of its issuance. Given in the city of Bogotá, on the 21st day of July, 2025.
